The Freedom Of Choice Act & Mr. Obama's Abortion Agenda

While many Americans watched President Barack Obama's inauguration, his team was working behind the scenes to implement the most radical abortion agenda in our Nation's history:

- ⊙ The Obama Administration has taken steps to reverse a policy first implemented by President Reagan to keep our tax dollars from funding abortions overseas. It's called the Mexico City Policy.
- ⊙ From Day One of the Obama presidency, a radical pro-abortion assault began.
- ⊙ President Obama has pledged to make it his top priority to pass the "Freedom of Choice Act" (FOCA) which would immediately overturn hundreds of reasonable restrictions on abortion.
- ⊙ Through the "Freedom of Choice Act," Mr. Obama and the 111th Congress want you and me to pay for abortions.
- ⊙ The "Freedom of Choice Act" will have the effect of forcing pro-life health care workers to participate in performing abortions.

The Freedom of Choice Act Bans Any Restrictions on Abortion and Forces Us to Pay!

If FOCA is passed, legal scholars agree that it would overturn the following current laws and controls on abortion:

- * 38 states' prohibitions on partial-birth abortion
- * 44 states' laws governing parental involvement
- * 40 states' laws significantly restricting late-term abortions
- * 46 states' laws protecting an individual health care provider's right to deny an abortion on grounds of conscience
- * 27 states' conscience protection laws affecting institutions
- * 28 states' laws requiring a mandatory waiting period before providing an abortion
- * 16 states' laws mandating ultrasounds before an abortion
- * 33 states' laws requiring counseling before an abortion
- * All 50 states' reporting requirements on abortion

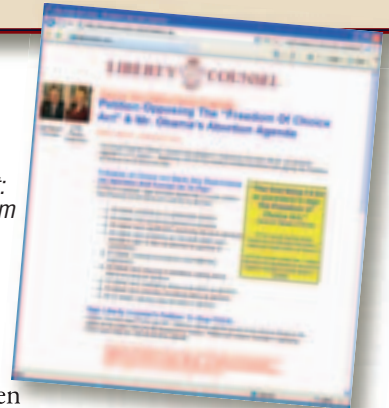

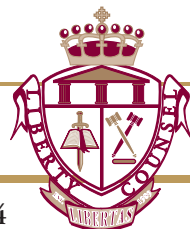
Liberty Counsel's Nationwide Petition States:

As a concerned citizen, I am signing this petition opposing the Freedom of Choice Act (FOCA) and other efforts by the Obama Administration and/or the 111th Congress to implement the agenda proposed by radical abortion advocates. FOCA would reverse the reasonable restrictions that have been placed on abortion (such as parental involvement laws, restrictions on late-term abortions, bans on partial-birth abortions, waiting periods and laws allowing counseling or ultrasounds prior to an abortion). FOCA also forces taxpayers and health care workers to violate their consciences by funding or performing abortions.

For these reasons, I oppose FOCA and efforts by the Obama Administration or Congress to reverse reasonable restrictions on abortion, require health care workers to participate in abortions, or impose taxpayer funding of abortions such as the lifting of the Mexico City Policy.

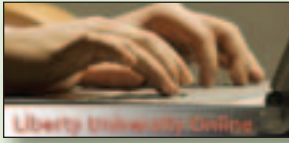
